#### 3. CONSENT CALENDAR

The draft meeting minutes for the May 08, 2013 Board meeting were reviewed for final approval.

*Motion/Second/Carried* – Ms. Thompson moved, seconded by Mr. Wilson, the motion carried unanimously to approve the minutes.

### 4. AMENDED 2013/2014 FISCAL YEAR BUDGET

Mr. Eck explained that subsequent to the approval of the budget for the Groundwater Authority for fiscal year 2013/2014 executed on May 8, 2013, it was discovered that certain amounts represented in Attachments A and D, did not match the information relative to the budget that was to be submitted to the County's Department of Finance at the end of June. Mr. Eck further explained that the proposed amended budget did not change previously approved expenditures or revenues; rather, the changes reflected adjustments to historical information for fiscal years 2011/2012 and 2012/2013 and corresponding adjustments in the fiscal year 2013/2014 budget relative to the Means of Financing and the Ending Fund Balance.

*Motion/Second/Carried* – Mr. Lowry moved, seconded by Mr. Kamilos, the motion carried unanimously to approve Resolution No. 2013-03 to amend the Authority's administrative budget for fiscal year 2013/2014 replacing Attachments A and D in the approved budget with amended Attachments A and D.

# 5. <u>DIRECTOR'S COMMENTS</u>

Brett Ewart, with the City of Sacramento, spoke on behalf of Mr. Peifer regarding an update on the drilling of a new groundwater well in the south part if the City. Mr. Ewart explained that previous environmental documentation had envisioned that the well would target an aquifer at the 250 foot range. Mr. Ewart stated that they have since come to the conclusion that the original target elevation for screening the well was not satisfactory so they planned to drill down to around 1,000 feet in order to target a more robust aquifer. Mr. Ewart explained that by drilling to the lower aquifer they did not expect a significant change in terms of capacity, but of water quality. The result would be a change in the project and a modification of the environmental documentation from the original project. Mr. Eck asked if they would be targeting the Mehrten Formation as opposed to the Laguna Formation. Mr. Ewart said

replied in the affirmative. Mr. Lowry asked if they planned on screening off at the 250 feet level and Mr. Ewart replied that they would not be pulling from that area but would go straight down and screen the well at 1,000 feet.
